

**GLACIER COUNTY COMMISSIONERS
REGULAR MEETING
Monday, April 12, 2010**

The Board of Glacier County Commissioners met at a regular meeting at 9:00 a.m. on Monday, April 12, 2010. Commissioners Michael DesRosier and Tony Sitzmann were present. Commissioner Ron Rides At The Door was not present for today's proceedings; he will be out of town on personal business. Clerk & Recorder, Glenda M. Hall was not present due to she was attending a District Conference in Great Falls for the day. Commissioner Michael DesRosier called the meeting to order.

9:00 a.m. Re-Visit Conway Weed Spray Contract

Larry Epstein told the commission that he received a call from Joe McKay. McKay stated to Epstein they don't want to argue. Epstein asked McKay what were their terms to agree on in order to settle. McKay replied that the Conway's wanted a guarantee to continue doing work for the county and the \$10,000.00 settlement. Bill Bandel added that he doesn't feel that the county should use Conway Weed Spray for work in the future and the BIA has also stated they feel the same about no future work. Commissioner Tony Sitzmann stands by the \$10,000.00 settlement as previously presented to Conway's. Epstein stated that there is no evidence that the spraying that Conway's allegedly did was ever really sprayed. Bandel added that for the last couple of years there had been solid Knapweed, once the county and BIA went out and did approximately twelve (12) hours of weed spraying there was a noticeable difference. Commissioner DesRosier agreed to the offer presented by Glacier County via letter. Epstein told the commission he would contact Joe McKay via letter.
