

**GLACIER COUNTY COMMISSIONERS  
REGULAR MEETING  
Monday, August 15, 2011**

The Board of Glacier County Commissioners met at a regular meeting at 10:00 a.m. on Monday, August 15, 2011. Commissioners Michael DesRosier and Tony Sitzmann were present. Commissioner Michael DesRosier called the meeting to order. Glenda Hall, Clerk & Recorder was present. Commissioner Ron Rides At The Door was absent due to personal business.

**10:00 a.m. Discussion/Approval: EMS Medical Director**

EMS Supervisor Amie Allison informed the commissioners that David Simpson had signed a letter of intent to be the new EMS Medical Director. She and Simpson reviewed the expectations and goals of the Glacier County EMS. The GCEMS had a state inspection last week and everything went good without any problems.

Commissioner Tony Sitzmann motioned to approve the hiring of David Simpson as the new EMS Medical Director for Glacier County EMS. Commissioner Michael DesRosier seconds the motion, the motion carried.

**11:00 a.m. Discussion/Approval: AFIS Purchase**

Commissioner DesRosier briefed Sheriff Billedeaux about his meeting with the auditors. They explained that if the Sheriff Department loses a deputy they should hold off hiring to fill the vacant position for a minimum of six (6) months. Sheriff Billedeaux told the Commission that Hooks Hideaway is having a shindig with fifty-two (52) bands and several bikers over Labor Day weekend. The summer is going good except for the prices of gasoline.

Sergeant Siefert told the commission that he received bids for the window covers for the new office building. Then he continued by explaining that AFIS is an Automated Fingerprint Information System. The U.S. Marshall Service paid for the new finger printing service for the Glacier County Sheriff Department. This program will help with the sexual and violent offenders. The GCSD is very fortunate to have this service provided for them at no cost.

Commissioner Tony Sitzmann motioned to approve the AFIS purchase provided by the U.S. Marshall Service at no cost to the Glacier County Sheriff Department. With no further discussion required, Commissioner Michael DesRosier seconds the motion, the motion carried.
