Commissioner DesRosier states not sure on amounts. Mike Kittson says he would like Resolution in hand. Clerk & Recorder Kennerly asked if Janine Scott, Clerk of District Court, is aware of this and was reassured yes.

Commissioner DesRosier asks for motion to approve Resolution #2018-18; John Overcast motions to approve Resolution #2018-18; Commissioner McKay seconded the motion; motion carried.

G. Discussion/Approval: Emergency Operation Plan- Charles Farmer, DES

Charles Farmer presented his Emergency Operation Plan which have been approved in sections, Charles explains the plan include far as flooding, storms, evacuation, massacre, and fire. Living working documents updated. Glacier County Commissioners has adopted all entities have agreed to Incident Command center. National Response Plan framework gives power back to the lower level (funding)

Babb, East Glacier, and Star School- unincorporated. Will participate- if don't participate pull funding. We need to cut funding. Citizens also need to help. All emergency begins and end at the local level. All entities come together. County, Tribe, Boarder Patrol, Fire department, national guard. We have an alert system.

Basic plan needs to be approved today, Emergency Operation Plan will be approved this year.

Commissioner McKay motions to approve the Emergency Operation Plan; Commissioner Overcast seconded the motion; motion carried.

H. Discussion/Approval: DOJ Interlocal Agreement- Clerk & Recorder & Mike Kittson, Human Resources

Merlin-I.T. use agreement. Mike Kittson recommends this to be approved every year, as it's a yearly process.

Michael DesRosier asks for a motion to approve the DOJ Interlocal Agreement; Commissioner McKay motions to approve the DOJ Interlocal Agreement; Commissioner Overcast seconded the motion; motion carried.

I. Discussion/Approval: Union v. Management Arbitration- Mike Kittson, Human Resources Director & John Evans, Glacier County Roads Supervisor

Mike Kittson states this item has been taken care of, but at some point in time he will talk with the Union to open the agreement and revise. John "Snoop" Evans, Road Supervisor

mentions that the contract is for 3 years and a new contract will be determined this year around March/April, usual timeframe.

J. Discussion/Approval: Bid Opening- Audit Proposals- Clerk & Recorder

Glacier County did not receive any bids for an audit proposal.

Mike Kittson explains the second corrective action plan for the Audit of Fiscal Years 2015 & 2016 for Glacier County is due by Friday, January 11, 2019. He would also like confirmation that we will not be asking for an audit proposal from Anderson Bros, CPA. The commissioner's confirmed that Glacier County will not be asking Anderson Bros, CPA for a proposal. Therefore, we do have company interested in submitting a proposal.

The commissioner's agreed to give Clerk & Recorder Kennerly permission to contact Todd Timboe of Wipfli/Joseph Eve for a bid proposal for Fiscal Years 2017 & 2018.
