The commissioners also asked her previously about inventory bought for summer events that the county did not receive back.

Litigation is covered by insurance. Lawsuit is not asking for money but injunction, meaning a broad complaint, oil & gas money being held up. May 18, 2017, Jolene Volksman sent report to schools. Also made a check \$647 to Melissa. Jolene purposely made 12 adjustments, made fictious/false statements. When asked Jolene why she said to catch Bob Denning but has created problems, which Don Wilson and Bob Denning are trying to fix.

Kyla Presnell said she read in the paper, how can Don Wilson be part of this lawsuit when Jolene Volkman did this?

Terryl Matt states this is still being investigated, Matt Dodd will have to address, which is a good question. Commissioner DesRosier states next step to set up meeting with Matt Dodd. Terryl Matt states that when Jolene Volkman was asked about a backup check, Jolene stated everything was there and refused to talk to us again.

The proposal for audit services was received in the Clerk & Recorder's office. Commissioner DesRosier states he needs approval, have proposal, State gave extension. We are up to date on audits, proposal to complete by June 30, 2019. Mandi Bird Kennerly, Clerk & Recorder recommends that the county go with Wipfli LLP for the fiscal year 2017-2018 Audits, the total cost will be \$96,500.00. She also adds it's difficult to find an auditor given the time line. The bigger firm will be able to get the county audit complete in the timeframe required by the Department of Administration.
