E. Discussion/Approval: 2019-2020 CASA Contribution-Kiersta Sullivan

Mike Bruch stated that Kiersta Sullivan was not able to make so he was here to present for her. First of all, he stated how they appreciate Glacier County for all of their support and the county has kept them from going under. This year they are asking for \$10,000 from each county. He also stated that Glacier County uses the most resources and is the most generous. They serve around 50 kids which costs around \$50-\$60 Thousand a year to take care of them. He expressed that the kids really need the services. Commissioner McKay stated that the CFO and Human Resource is meeting with department heads going over budgets and asked Mike if we could table until the next meeting to get the answer. Mike stated yes that they will take whatever they can get. Commissioner McKay stated to have it put on the July 23, 2019 agenda in Browning. Commissioner Overcast stated that he is aware of the importance.

F. Discussion/Approval: Mercantile Demolition/Feasibility Agreement-GC Commissioners, Stahly Engineering & Amy Overstreet, Cut Bank Chamber

Commissioner McKay stated his understanding is Amy Overstreet and Commissioner DesRosier received information from Stahly. Amy Overstreet stated she talked with Robbie this morning about detail scope of work and fee estimate. Commissioner McKay read email that was received from Robbie at Stahly about Phase 1 the Feasibility Study. The estimate for the completion of Phase 1 is \$10,000.

Commissioner Overcast motions to allow Stahly to proceed with feasibility study/develop scope of work; Commissioner McKay seconded; motion carried.

Commissioner Overcast stated that they Port Authority money would be used. Amy Overstreet stated that she also talked with Jason Skyler at DEQ to see if the money was still available, he stated "Yes" they saved \$50,000 for Glacier County but would like to be onsite.

Commissioner McKay would like for the finalize agreement/feasibility study for Mercantile and the on-site evaluation and overall initial planning on the agenda for Monday July 15, 2019.
