D. Discussion/Approval: Jail Alternative Program CARES Reimbursement Contract-Vernon "Napi" Billedeaux & Jody Hickey, Glacier County Sheriff Office
Jody Hickey, Civil Secretary explains The Jail Alternative Program started out as The
Board of Crime Control Grant. They found a way to get reimbursed through CARES Act,
complete coverage and still maintain social distancing. Allows house arrest 24/7 with an
ankle bracelet. They will hire a compliance monitor @ \$16.00 per hour which is part time
right now and could possibly work into a full-time position through Compliance
Monitoring Systems.

Jody also explains there is training available through the grant. They will purchase an iPad for prisoner to have attorney visits etc. This will give people a chance to show that they are willing to reform. The judges have already started to work with the program also. The liability stays with the Compliance Monitoring. The contract is from October 2020 to October 2021.
