Commissioner DesRosier explains the meeting schedule as we have a new commissioner to the board. Commissioner Bremner explains that she is on the Montana Board of Education until February 1, 2021. She did state that she has reapplied for the position and if chosen for the term the meetings will be every three months for two days (Wednesday & Thursday), occasionally on a Thursday & Friday. Commissioner DesRosier states that this shouldn't be an issue.

Commissioner Overcast motions to approve Resolution No. 2021-01 2021 Annual Commission Meeting Schedule; Commissioner Bremner seconds the motion; motion carried.

E. Discussion/Approval: NexHealth Program Purchase – Jenny Krapf, Glacier County Health Department

Jenny Krapf, Glacier County Health Director explains that the NexHealth Program is a move into the future of scheduling patients for shots, vaccines and it will help streamline patients. This program will allow us to do the different phases of things like the flu shot, COVID-19 shots and immunizations. She states that the cost for 1 year is \$5,400.00 and after a year if its sustainable we will keep the program, but if not, we wouldn't renew next year. Commissioner Overcast asks if this program is paid by a grant. Jenny states that will be covered by CARES Act funds this year. Commissioner DesRosier states that Jenny would be the person who would know and understand what is needed to best serve our health community.

Commissioner Overcast motions to approve the NexHealth Program purchase of \$5,400.00 with CARES Act Funds; Commissioner Bremner seconds the motion; motion carried.

F. Discussion/Approval: Appoint Glacier County Board of Health Recommendation – Glacier County Board of Health/Glacier County Commissioners

Nancy Hjartarson, Glacier County Board of Health Chair introduces herself to the commissioners. She states that they had a member resign and there is a year left on that board position. They had (5) applicants apply for the position and the board would like to recommend Dr. Danielle Kennedy to fill the remainder of the one-year for this term. The board positions are non-paid positions. She also states that they will have a 3-year term expiring in January and the board member who already fills this position would like to reapply. Jeff Severn who is certified in infection control at Indian Health Service fills this position at the moment and is interested in serving again. Nancy explains that they try to fill the board positions with individuals from each health care entity in the county and have been very successful in having volunteers do this. Commissioner DesRosier explains how the commissioners are involved with boards of the county.

Commissioner Bremner motions to appoint Dr. Danielle Kennedy to the Glacier County Board of Health to fulfil the one-year left in the 3-year term; Commissioner Overcast seconds the motion; motion carried.

LeAnne Kavanagh, Press states that Dr. Danielle Kennedy is a great fit to the board. She has already accomplished so much in the county.

Commissioner Bremner asks if she can get a copy of the COVID-19 protocol for Glacier County. Jenny Krapf, GC Health Director will get the mandates and email them to you.

OTHER BUSINESS:

G. Public Comment

LeAnne Kavanagh, Press asks if Glacier County is on schedule to send out the revised tax bills. Commissioner DesRosier states that he doesn't know and that LeAnne should ask Don Wilson, Treasurer. LeAnne reminds Commissioner DesRosier that Treasurer Wilson will not answer her questions. Mike Kittson, GC HR Director & Commissioner DesRosier leave the chambers to get Treasurer Wilson. Upon return Treasurer Wilson, LeAnne and the commissioners have a discussion on the timeline of the revised tax bills going out. It is stated that the bills will go out in the next few weeks.

Carol Larson, Public asks if Glacier County is still paying the schools. Don Wilson, Treasurer states "Yes, by law we have to pay them out within two days."

Commissioner DesRosier asks Don Wilson, Treasurer about the Cash Reports. Don Wilson, Treasurer states that he is unable to do the cash reports because he can't post the taxes yet from November. Although, I should post them by the end of the week or the first part of next week. Then I will be able to do the November distribution of taxes and the very next day distribute the December taxes.

Commissioner DesRosier asks Clerk & Recorder Mandi Bird Kennerly about the Browning Satellite Office Clerk & Recorder Employee. A discussion is had about the employee & about the Browning Satellite Office potential properties that Glacier County is looking into

buying. LeAnne Kavanagh, Press asks Commissioner DesRosier if she can ask a question regarding the Browning Satellite Office and Commissioner DesRosier states that this is not a public item, that it is internal and no she cannot comment.
