NOTICE OF GLACIER COUNTY'S INTENT TO PURCHASE A BUILDING FOR USE AS A SATELLITE OFFICE

Glacier County hereby gives notice of its intent to purchase the property formerly known as **"Blackfeet Construction Supply," in the amount of \$203,000; located at 503 SE Boundary, Browning, MT 59417 for use as a Satellite Office.** This office will ensure the County's ability to provide elections services as well as other critical government services to the western end of the county residents. Services to be provided include, voter registration and voting in person, vehicle registration and driver's license testing.

Property description: Main building 4,120 SQFT, Secondary building 3,920 SQFT, Third building 594 SQFT. The nature of the funding for this purchase is a private grant, received from the Center of Tech and Civic Life to support Election activities. This property meets the requirements for an elections office; location and access, area for parking, ADA compliant, adequate interior space for elections, as well as, additional space for other county satellite services.
