**2 Bids Received**

1. RDO Equipment Co. - \$346,700.00 – including warranty costs, of one, new 2021 or newer motor grader. Motor grader manufacturer: John Deere Model & Year: 772G, 2021. Bid Bond is ok.
2. Tractor & Equipment Co. - \$317,357.00 – including warranty costs, of one, new 2021 or newer motor grader. Motor grader manufacturer: Caterpillar Model & Year: 2021 150AWD. Bid Bond is ok.
