E. Discussion: Mid-Term Insurance Review – Leavitt Group

Commissioner Bremner starts with introductions and asks for the commissioners to respond with their expectations of the insurance. There is a discussion on the safety programs offered and how Leavitt can assist the county in helping implement more safety for the Glacier County Employees. Jake Gustafson, Travis Clark and Jay LeProwse, Leavitt explain that they have started the safety program with Shannon Pepion, Glacier County Safety Coordinator and that it's been working great, but they will continue to improve where it's needed and assist in any way possible. There was also talk back and forth about safety training, incentive programs and their walk-through program.

There is discussion on the Worker's Compensation and how it's being handled with the Montana State Fund. There is also discussion on the Employee Benefits Advisor Nick Prinzing and how he can assist employee's with wellness programs offered. Commissioner Bremner is asked to sign two documents: 2021-2022 PCT Renewal Scheduled Property to start the process of getting a cost for the upcoming year and the Rating Data Sheet so that the EMOD can be found for the Worker's Compensation Trust with Montana State Fund.

F. Approval: Grader Bid Opening (4) – John "Snoop" Evans, Glacier County Road Supervisor

Commissioner Bremner states that this item was advertised for 10:00 a.m. and it is 10:31 a.m. She states that John "Snoop" Evans, Glacier County Road Supervisor couldn't be present and sent his apologies.
