C. Discussion: Presentation on East Glacier Women's Club Tax Exempt Status – East Glacier Women's Club

Judy Moats, Public was able to get the East Glacier Women's Club to a tax exempt and property exempt status. She states that the EGWC closed because of COVID-19 last year. We do have windows purchased and they need to be put in. EGWC has received money received from the Glacier County Regional Port Authority. We have put off the fixing of the roof.
