The Glacier County Board of Commissioners met at a regular scheduled meeting at 9:20 a.m. on Tuesday, September 14, 2021. Commissioners Mary Jo Bremner and John B. Overcast was present. Commissioner Michael J. DesRosier was absent.

B. Approval of Agenda

D. Discussion: Browning Community Concerns/Issues

Commissioner Bremner gives an update on the new Browning Satellite Office. It has been painted and it looks really nice. I let the Browning Satellite Office Treasurer Clerk's pick the color of the office which was a blue/gray color. There are a few things that we need to put out to contract. We hope to be in the building soon. We have engineers from Stahly Engineering & Associates, Inc. that will be looking at the parking lot to see what we need to do to get it fixed. We will address the parking lot first because we need to enter the building safely. Stahly gave us a date and we have to wait for them to get that done. I know we've had a lot of interest in when we will be in the building. We have an extension agent that we need to house and we will have space designated for nurses. She would like to have someone in the Browning office once or twice a week. Just to cover some things that might not be offered. She's not trying to replace any health programs in Browning, but if there are people in the Babb/East Glacier or outlying areas that need to utilize the Glacier County Health Program then they will be able to do that. We also need space for elections, and we want to remodel the annex to hold the elections. We're talking to Siyeh Communications for high-

speed internet connection. They will be running a fiber optic line to our building soon. We will also be getting the Treasurer's Office the secure access they need to have for their State of Montana computers. We have no community members here for concerns or issues.
