The Glacier County Board of Commissioners met at a regular scheduled meeting at 9:00 a.m. on Thursday, February 17, 2022. Commissioners Mary Jo Bremner, John B. Overcast, and Michael J. DesRosier were present. Austin Parrent taking minutes.

NEW BUSINESS:

D. Discussion (9:30 a.m.): Glacier County Insurance Claim Process – Leavitt Group Jake Gustafson, Leavitt Group Insurance; talks bout a few claims that has been submitted recently. The first one being the roof that blew off one of the shed out at the Airport. The second one is a pipe had broken in one of the rooms at the Courthouse, Commissioner Bremner gives a brief overview on the progress that is being made of the broken pipe, and the third one is a claim from the West End Cemetery.

Commissioner DesRosier mentions the Library Claim that was submitted. Shannon Chamberlain, MACo; explains that what happened with this claim was the lack of communication between Pro Clean and whoever was supposed to be in contact with them. The Travelers adjuster is saying that the mitigation invoice was not acceptable. It was above and beyond on what should have been done to Travelers is denying it so MACo has no choice but to deny it because they had already paid up to \$100,000.00. Pro Clean stated that they had permission to keep everything running.

Commissioner Bremner states that there was no communication between the Commissioners and the library board as well. Commissioner Bremner praises Austin Castle, Glacier County Library Director; on how well he is communicating with everybody since he has started his new position. Shannon recommends that in the future when there is a claim to be submitted that there is a designated contact person if anybody has any questions, or they need an update on how things are going. Becky Kimmett, Library Board Member; states that to her knowledge Shannon Pepion, Glacier County Maintenance Department Head was the person of contact for the library claim that had been submitted. Travis Clark with Leavitt Group Insurance asks Becky where they are at with the claim and Becky states, she does not know what the holdup is. Commissioner Bremner and Becky discuss the money that the insurance company had given them. Becky explains a possible litigation problem and Terryl, Glacier County Attorney; had not gotten back to them on the matter. Discussion about getting things rolling with the Browning Library continues.

Commissioner Bremner asks about the West End Cemetery and if the insurance will cover the damage that has been done. Shannon explains that there is some coverage for Glacier County Property when they are on a schedule. The headstones at the Cemetery are not on a schedule so there is not coverage for repairs on the headstones. Shannon explains that if security lights and a fence is put up, that they need to make sure Leavitt knows so it could be put on the schedule.

Travis mentions a couple other claims that need to be closed out for Glacier County.

E. Discussion/Approval (10:00 a.m.): Meeting w/ Glacier County Elected Officials – Mary Jo Bremner, Glacier County Commission Chair

Commissioner Bremner thanks that elected officials that showed up today and explains that she would like to hear how things are going in their offices and would each official to give a report on their budget. Vernon "Napi" Billedeaux, Glacier County Sheriff; explains his expenditure budget and how they are looking for alternate funds for the jail meals because they increased. Napi gives an overview of the calls they have received and how many inmates they have been averaging. Napi explains how Jody Hickey, Glacier County Sheriff's Office Civil Secretary has been doing an excellent job on writing the grants for the Sheriffs office.

Twila Pyette, Glacier County Clerk of District Court; explains her budget is doing good at 43% used so far. Twila mentioned she increases the jury expenses this year and she may increase again next year. Twila explains how she would like to update her current copier because it is not compliant with the state security. Twila also talks about the courtroom leaking because of the snow on the roof and the current heating situation. Commissioner Bremner assures Twila that they are working on getting the heating system working the way it is supposed to.

Carolyn Berkram, Glacier County Justice Court; explains that her budget is at 56% in her expenditure budget. Carolyn discusses with the Commissioners the letter that she had received on February 3, 2022. Commissioner Bremner cuts Carolyn off and tells her to submit her concerns about the letter in an email. Carolyn stats that this will be the last time she attends a meeting like this. Commissioner Bremner states that she did not mean for the meeting to be confrontational.
