D. Discussion/Approval: COVID Leave – Michael Kittson, Glacier County Human Resource Director

Michael Kittson, Glacier County Human Resources Director; explains how COVID has been affecting the employees of Glacier County and their sick leave. Mike is asking permission from the Commissioners to amend the current sick leave policy for new employees. Mike explains to the Commissioners the new policy he would to be set in place. Commissioner Bremner asks if budgets support the new policy? Mike assures the commissioners that he is focusing on the amount of leave an employee can donate. He would like to allow employees to be able to donate 120 hours instead of only 40 hours in a year.

Commissioner DesRosier motions to allow Michael Kittson, Human Resources Director; to makes the changes to the COVID Leave; Commissioner Overcast seconds the motion; motion carried.

E. Discussion/Approval (11:00 a.m.): CCIP Plan – Robie Culver, Stahly Engineering & Glacier County Commissioners

Robie Culver, Stahly Engineering; talks to the Commissioners about some projects, facilities, roads, bridges, ect. Commissioner Bremner states that she would like Robie to attend the department head meeting they are planning for March 17th. Robie states that the 17th will work out fine, gives them time for a press release. Further conversation happens about what Robie will present during the department head meeting and the survey that will be given out.

F. Discussion/Approval: (11:00 a.m.): Potential ARPA Manager – Robie Culver, Stahly Engineering & John B. Overcast, Glacier County Commissioner

Robie Culver explains how the ARPA funding should be used and how Glacier County must report it. Robie also explains that the Montana Minimum Allocation Grants that came from HB632 will have to applied for. Robie talks about what she has been doing with some other counties that she has worked with. A lengthy conversation continues about what an ARPA Manager does/helps with and what a staring cost would be. Commissioner Bremner would like to table deciding on the item until the Commissioners can read through a proposal. Robie asks what the outreach is for what the communities need with those minimum allocation funds. Chancy Kittson, Glacier County CFO; explains that three different Hutterite Colonies were the only ones to come in asking about water/sewer projects through ARPA funds. Robie explains technical assistance through Commerce and other application sources. Commissioner Bremner asks Robie to explain the infrastructure bill that is being pass by the president if she can. Commissioner Bremner hopes that the DOA and DOR so not get in the
