NEW BUSINESS:

D. Discussion/Approval: Glacier Care Center IGT Funds – Glacier County Commissioners

Chancy Kittson, Glacier County CFO explains that this is an Intergovernmental Transfer Program for the Glacier Care Center which spans the period from July 1, 2021, through June 30, 2022. The SFY2022 agreement for a one-time voluntary intergovernmental transfer with a lump sum payment of Medicaid monies for "at-risk" county affiliated nursing facilities. The COUNTY, shall make an intergovernmental transfer of monies to the DEPARTMENT in the amount of \$145,153.31. Then the transfer by the COUNTY to the DEPARTMENT of the total amount allows for the payment by the DEPARTMENT of the lump sum nursing facility payment to the Glacier Care Center of \$197,845.83 as implemented through this agreement. There is a discussion that the county takes a portion of the county wide mill levy to fund this payment every year. Commissioner DesRosier states that the county had agreed to this obligation many years ago.

Commissioner DesRosier motions to approve the Glacier Care Center IGT payment to the Montana DPHHS Senior and Long-Term Care Division for the SFY2022 (July 1, 2021 through June 30, 2022); Commissioner Overcast seconds the motion; motion carried.

Chancy Kittson, Glacier County CFO explains each resolution to the commissioners. We will be amending the FY2021-2022 budget to reflect unanticipated revenue received after the budget was approved. The unanticipated revenue will go into the appropriate funds of 2220 – Library, 2300 – Sheriff Department; 2964 – Sexually Transmitted Diseases (STD); 2968 – Chronic Disease Prevention Fund; 2972 – Family Planning Grant & 2976 – Immunization Grant. When in the process of amending the current budget there are two public hearings during the regularly scheduled commissioner meetings. We will put these resolutions on the Monday, May 16, 2022 agenda for approval.
