# C. Discussion/Approval: Allocation of Glacier County ARPA Minimum Allocation Grant Funds – Kim Winchell, City of Cut Bank Mayor

Kim Winchell, City of Cut Bank Mayor, reads her request to utilize the American Rescue Plan Act (ARPA) Minimum Allocation Grant funding:

"Good morning and thank you for having me. My name is Kim Winchell, I am here as Mayor of Cut Bank. Glacier County has access to \$1,047,000 monies thru the ARPA Minimum Allocation Grant dollars.

As you well know, this is truly use it or lose in money. It would be devastating for these funds to go unused and get absorbed for redistribution. The City is in need of these funds to help alleviate the cost to replace the falling apart water tank on the hill. This project scope of permissible use, but only the County can sponsor the application to get the funds released. The total project cost is \$4.5M. We have sought out a \$2M Competitive grant but even still, have a gap in the funding of over \$2.5M. If we have to pass the full cost to the residents of Cut Bank, it will add \$7.00 per month, to an already extremely high water and sewer bill.

Our ask and proposal, is should the County agree to sponsor the application, our engineering firm who I believe has dialed in this morning, has agreed to not only handle the application process, but also handle the reporting as well, and the City will also step in anywhere needed throughout the process. The County has an opportunity to make a considerable difference for the Cut Bank community while incurring no cost and almost no work. I believe all that would

be required would be the signature. I also reached out to Robie Culver of your Stahly Engineering, so it is on her radar as well.

As you can see, I've printed out various scenarios of the different rate increases to the community, depending on how the final structuring of the finances plays out.

I thank you for your time this morning and hope myself or Craig can answer any questions you may have."

### Scenario Attachment Letter:

"Hi Kim,

I ran several different scenarios and have listed them from worst case scenario to best case scenario. I ran a couple with loan forgiveness and a couple without, not knowing for sure whether it will happen.

A \$1 million allocation of ARPA funding from the County would have a \$3/per month impact to the users. Basically, every \$100,000 borrowed has a \$0.30 per month impact to the users.
