The Glacier County Board of Commissioners met at a regular scheduled meeting at 9:00 a.m. on Tuesday, May 3, 2022. Commissioners Mary Jo Bremner, Michael J. DesRosier and John B. Overcast were present. Michael Kittson taking minutes.

A. Roll Call

Meeting called to order at 9:01 a.m.

B. Approval of Agenda

Commissioner DesRosier motions to approve the agenda with no changes; Commissioner Overcast seconds the motion; motion carried.

NEW BUSINESS:

C. Discussion: Highway 2 Association Dues – Glacier County Commissioners

Commissioner Bremner asks Commissioner DesRosier to discuss the Highway 2 Association dues. Commissioner DesRosier states that the Highway 2 Association lobbies for improvement to Highway 2. He states that Bob Sievertson is the President of the association and the annual dues are \$100.00. Commissioner Overcast will be representing Glacier County on the board.

Commissioner DesRosier motions to support the Highway 2 Association and pay the dues of \$100.00; Commissioner Overcast seconds the motion; motion carried.

D. Discussion/Approval: East Glacier Hydrants/DNRC Grant Application – Mike Wikstrom, East Glacier VFD/Glacier County Commissioners

Mike Wikstrom, Glacier County East Glacier Volunteer Fire Department Chief talks about the DNRC Application and he will discuss it later when it's ready. He also explains that they are in need of replacing (5) fire hydrants and he asks for direction on a solution to assist in the payment of this project. The estimated cost will be between \$2,500.00 and \$3,000.00. Commissioner DesRosier discusses the history of past replacement of the fire hydrants. He recommends discussing this with Two Medicine Water or the Blackfeet Tribe. The commissioners continue to discuss the project and want Mike W. to get cost information and they will see if there are any options to help with the funding. No action was taken.

E. Discussion/Approval: Accept (2) Donated Fire Trucks for Del Bonita VFD – Walter Barry, Del Bonita VFD/Glacier County Commissioners

The DelBonita Volunteer Fire Department received (2) donated fire trucks from the West Valley Fire & Rescue in Kalispell. This item was put on the agenda to formally accept the two fire trucks as Glacier County DelBonita VFD property and they can register/license/insure both of the units.

Commissioner DesRosier motions to accept the (2) fire trucks donated to Glacier County DelBonita VFD; Commissioner Overcast seconds the motion; motion carried.

F. Discussion/Approval: Nomination Form for River View Dairy Barn/Historic Places – Glacier County Commissioners

Commissioner Bremner received a nomination form to list the River View Dairy Barn, west of Cut Bank in the National Register of Historic Places. The commissioners discuss and would like to sign the designation as long as the county does not have any financial obligation.

Commissioner DesRosier motions to sign the request to list the River View Dairy Barn, west of Cut Bank in the National Register of Historic Places; Commissioner Overcast seconds the motion; motion carried.
