Tuesday, June 14, 2022
Regular Meeting
Browning, MT**

The Glacier County Board of Commissioners met at a regular scheduled meeting at 9:00 a.m., Tuesday, June 14, 2022. Commissioners Mary Jo Bremner, Michael J. DesRosier and John B. Overcast were present.

Present at the Meeting: Lanaina Upham, Glacier County DES Director; Vernon “Napi” Billedeaux, Sheriff & Maurice Redhorn, Undersheriff Glacier County Sheriff Department; Verna Billedeaux, MSU Blackfeet Extension; Chancy Kittson, Glacier County CFO

A. Roll Call

The meeting was called to order at 9:00 a.m.

B. Approval of Agenda

Commissioner DesRosier motions to add approval for the Glacier County Contract Rate for Rental space and Michael Kittson, Glacier County Human Resource Director will provide the information; Commissioner Overcast seconds the motion; motion carried.

Michael Kittson, Glacier County Human Resource Director presents the statistics of the rental rates in and around Glacier County that would be comparable to our area such as: Toole County, Pondera County & Teton County. He also shows the lease summary information for the Department of Corrections around the State of Montana. It is decided that the rental rates will need to be increased going forward.

Commissioner DesRosier motions to increase the Glacier County Contract Rental Rate to \$14.00 per square foot; Commissioner Overcast seconds the motion; motion carried.

C. Discussion/Approval: 2022 Charging Home Stampede 4-H Fair Contribution (\$5,000.00) – Glacier County Commissioners/Verna Billedeaux, MSU Blackfeet Extension

Verna Billedeaux, MSU Blackfeet Extension is present to request \$5,000.00 from Glacier County in support of the Annual 4-H fair held at the Stampede Park in July. There is a discussion about the fair and that the county has been supporting the 4-H fair for numerous years. It is decided that they will contribute \$5,000.00.

Commissioner DesRosier motions to contribute \$5,000.00 to the Annual 4-H Fair held at the Stampede Park in July; Commissioner Overcast seconds the motion; motion carried.

D. Discussion: Additional Follow-up Allocation of Glacier County ARPA Minimum Allocation Grant Funds – Glacier County Commissioners/Chancy Kittson, Glacier County CFO

Chancy Kittson, Glacier County CFO presents the ARPA allocation funds update. He and the commissioners mostly discuss the water/sewer funds that are for projects within Glacier County. They have had applications from the City of Cut Bank and Hutterite Colonies. Chancy discusses the process to get funding for those entities. He also discusses that the Airport Board is interested in submitting an application, but he will follow up with them. No decisions were made.
