C. Discussion/Approval: Resolution No. 2022-16 FY2022-2023 Elected Officials Compensation – Michael Kittson, Glacier County Human Resource Director

GLACIER COUNTY RESOLUTION FY2022-2023 ELECTED OFFICIALS COMPENSATION Resolution No. 2022-16

WHEREAS, THE Board of Glacier County commissioners has reviewed and considered all sources of revenue and all necessary requirements of the County and its employees; and,

WHEREAS, THE Board desires to make timely provisions for the compensation and benefits provided to the elected officials, deputies and employees of Glacier County; and,

WHEREAS, Section 7-4-2503, MCA, provides for incremental increases in salary on the basis of the previous year's consumer price index as calculated by the U. S. Department of Labor, Bureau of Labor Statistics or other index is adopted by the Bureau of Business and Economic Research of the University of Montana – Missoula as a successor thereto; and,

WHEREAS, said increment index has been set at a cost-of-living increase of 4.7% for adjustment of salaries for the Fiscal Year 2023 by said Bureau of Business and Economic Research.

NOW, THEREFORE, BE IT RESOLVED, that all salaries and wages of county officers, employees and officials shall be, and are hereby approved to receive 7% COLA at an

amount not to exceed the amount currently set for the Fiscal Year ending June 30, 2023. Another governing board (i.e., Library, etc.,) may set their own salaries at a different amount.

Michael Kittson, Glacier County Human Resource Director explains that the Glacier County Compensation Board met twice regarding wages for elected officials. It was recommended & approved to give some elected officials a 7% COLA increase for the FY2023 fiscal year. The Sheriff's office is different due to a statute change so last year they received a 3% increase in addition to any official compensation given. They were in need of an increase to be in line with their longevity since they were not able to get the longevity since Fiscal Year 2018. The Glacier County Attorney was set to increase due to her Deputy County Attorney being so close to her wage.

D. Discussion/Approval: Schedule Department Head Reviews – Michael Kittson, Glacier County Human Resource Director

Michael Kittson, Glacier County Human Resource Director hands out a draft performance review form to the commissioners. He states that it will be for the supervisors, and they will need to do performance reviews every year. He recommends that when the commissioners sit down with department heads that they will use this form when deciding on raises/reviews. There is a lengthy discussion on how this should be addressed and the steps to take to get this implemented with the department heads. No decision was made today, just review of what the process should look like.
