D. Discussion/Approval: Montana Department of Corrections Lease Agreement (G.C. Annex) – Glacier County Commissioners/Michael Kittson, Glacier County Human Resource Director

The lease agreement between Glacier County and the Montana Department of Corrections is presented with the following changes:

Term of Lease Agreement: 10/1/2022 through 9/30/2027 – 5-year lease \$959.71 monthly \$11,516.50 yearly \$15.50 per square foot

Michael Kittson, Glacier County Human Resource Director explains that the county has leased to Montana Department of Corrections for probation and parole in the Glacier County Annex and the lease was needing to be renewed. Chancy Kittson, Glacier County Chief Financial Officer and I talked about the lease and looked into the rates to see if the county was charging the proper amount for the space being leased. They took into consideration the cost that the lessor was incurring (plowing, maintenance, insurance & utilities) and also looked at the State of Montana's Comparative Leases for the State/Region/County. As a county we're not revenue generating, but we don't want any of the cost to run the building to go on the taxpayers of the county. When working with the state we were able to negotiate a 2% increase after year one and going forward until the lease renewal. The commissioners thanked Michael & Chancy for their hard work in getting new square footage rates as it is a process.

Commissioner DesRosier motions to approve the renewal lease between Glacier County and Montana Department of Corrections; Commissioner Overcast seconds the motion; motion carried.
