### Glacier County Commissioners Monday, March 20, 2023 Regular Meeting Cut Bank, MT

The Glacier County Board of Commissioners met at a regularly scheduled meeting at 9:00 a.m. Monday, March 20, 2023. Commissioners Mary Jo Bremner, Vernon "Napi" Billedeaux, and John B. Overcast were present. Austin Parrent taking minutes.

### B. Approval of Agenda

Commissioner Billedeaux motions to approve the agenda with no changes; Commissioner Overcast seconds the motion; motion carried.

# C. Discussion/Approval: Glacier County Attorney/Matt Law Office Cost Share Agreement – Glacier County Commissioners/Terryl Matt, Glacier County Attorney & Owner Matt Law Office

Glacier County Attorney Terryl Matt presents a request to the commissioners for approval to pay the full amounts for her monthly copier costs and shredding service costs for both the Glacier County Attorney's Office and Matt Law Office from the Glacier County Attorney's budget. The copier lease agreement is through Kelley Connect and costs an approximate \$500-\$550 per month plus the overage costs of color copies for that month. This copier lease agreement ends in October, at which point Human Resources Director Mike Kittson will assist the Glacier County Attorney's Office in finding a copier lease agreement at a reduced monthly cost. The Iron Mountain shredding service costs an estimated \$70-\$100 every few months. There was discussion on combining the monthly Iron Mountain bill with the Human Resources/Payroll account.

### **Public Comment:**

Laurie Elhard makes a public comment, asking if these costs cover only county business and not personal business. Terryl Matt responds that the costs would cover both since they cannot be distinguished. She also mentions that previous county attorneys had their electric bills and rent paid for in prior cost share agreements.

Commissioner Overcast asks about the paper cost for the copier. Terryl Matt responds that she personally pays for the cost of the paper and the agreement would be to cover the full amounts for both the copier lease agreement/printing costs and the shredding service costs.

Commissioner Billedeaux motions to approve the copier costs and shredding costs for the Glacier County Attorney's Office and Matt Law Office from the Glacier County Attorney's budget; Commissioner Overcast seconds the motion; motion carried.

## D. Discussion/Approval: Update Center for Mental Health/Mill Levy – Sydney Blair, Center For Mental Health CEO

Sydney Blair, Center for Mental Health CEO (now dba: Many Rivers Whole Health), presents to the commissioners what services Many Rivers Whole Health currently offers and discusses what services they would like to expand into in order to better serve rural communities' mental health needs. Commissioner Billedeaux and Sydney Blair discuss law enforcement's frequent encounters with individuals who are needing mental health professional services. Sydney Blair talks with the commissioners about how a fee for service model typically does not provide all the support a community needs to address its mental health needs. She presents different ways that counties contribute to help provide additional support for their communities' mental health needs.

Sydney states that one of the ways Glacier County helps is by providing a reduced rent for space they occupy out at the Glacier County Annex Building. Sydney also mentions the effect that levying mill levy money has had on additional services and how it helps with associated travel costs. She also talks about expanding substance abuse services within Glacier County if the commissioners would like to expand services in that direction. There is an additional discussion on the increased mental health services that Many Rivers Whole Health was able to offer due to being a grantee of a Substance Abuse and Mental Health Services Administration (SAMHSA) grant for two years.

No action was taken as the commissioners would like to give Sydney Blair a chance to submit a formal written proposal.

## E. Discussion/Approval: Library Board Member Recommendation & Appointment – Austin Castle, Glacier County Library Director

Austin Castle, Glacier County Library Director, presents the Glacier County Library Board's recommendation to appoint Leanne Zainer to the Glacier County Library Board.

Commissioner Overcast motions to approve the appointment of Leanne Zainer to the Glacier County Library Board; Commissioner Billedeaux seconds the motion; motion carried.

# F. Discussion/Approval: Update on Glacier Care Center Lease – Michael Kittson, Glacier County Human Resource Director

Michael Kittson, Glacier County Human Resources Director, discusses updates with the commissioners regarding a proposed Glacier Care Center lease to an interested party known as Foundation. One of the requirements in the general obligations bond which was used to

purchase the facility is that a non-profit operates the facility. Mike states that he discussed with the county attorney the possibility of doing a month-to-month lease agreement until both parties agree to end the lease. A caveat listed in Montana Code Annotated (MCA) is that the lease transition will require a 5-week minimum notice period before the new providers can take over the lease.

He would like to get the commissioners' questions and concerns and any final changes to the proposed agreement. There is additional discussion on possibly needing a mill levy to help fund the Glacier Care Center and the necessity of public awareness and involvement in the issue to get one passed if they plan on going that route. In addition, Mike discusses the importance of getting the public to talk to their legislators in order to advocate for raising Medicare and Medicaid reimbursement rates to rural healthcare facilities.

No action was taken on this item.

G. Discussion/Approval: February 2023 Cash Report – Glacier County Commissioners Glacier County Treasurer Don Wilson presents the February 2023 Cash Report to the commissioners and discusses the Montana Code Annotated deadline by which it is due each month.
