# C. Discussion/Approval: Renew Carlyle Consulting Contract (I.H.S.) 3/1/2023-3/1/2024 (\$5000.00 per month) – Glacier County Commissioners

The Glacier County Commissioners discuss renewing the Carlyle Consulting Contract after an invoice from Carlyle Consulting was received for March 2023 services in the amount of \$5,000.00. The prior contract ended March 1, 2023 and does not cover the March 2023 invoice which was received. The commissioners have a lengthy discussion on the services provided by Tom Rodgers of Carlyle Consulting and a history of why his services were contracted in the past. All three commissioner agree to reject the renewal of the Carlyle Consulting contract at this time but to pay the invoice received for services rendered in March of 2023.

This list includes the following state approved treatment centers listed on the form: Alpenglow Clinic LLC, & Crystal Creek Lodge Treatment Center. They would also like to have the treatment facilities submit a formal request to be considered to receive a portion of the earmarked alcohol tax distribution and come in to present their request inperson or via conference phone. All three commissioners would like to table this item until more information can be gathered and formal requests for distribution are made.
