F. Discussion/Approval: Glacier County CCIP Update – Glacier County Commissioners/Stahly Engineering

H. Discussion/Approval: Presentation on Employee Health Insurance Program – Michael Kittson, Human Resources Director

Human Resources Director Michael Kittson and Payroll Clerk Carolyn Popelka do a presentation on the employee health insurance program and present the new rates for Fiscal Year 2023-2024.

I. Discussion/Approval: Rate overview and contract with Montana Blue Cross Blue Shield for Health Insurance – Michael Kittson, Human Resources Director

Human Resources Director Michael Kittson presents the new county contribution rate of \$842.28 per employee noting an increase of \$51.78 from FY2022-2023. Medical coverage will remain the same. Dental coverage increased from \$3,000.00 to \$5,000.00 for the max annual benefit. Vision coverage rates stayed the same but added both glasses and contacts coverage. Life coverage rates remained the same. Montana Blue Cross Blue Shield will remain the insurance provider for Glacier County for Fiscal Year 2023-2024.

J. Discussion/Approval: Set Glacier County contribution for Health, Vision, Dental, Life Insurance – Michael Kittson, Human Resources Director

HR Director Kittson asks the commissioners to approve the county contribution increase of \$51.78 and bring the total county contribution to \$842.28 per employee.

Commissioner Overcast motions to approve the \$51.78 county contribution increase bringing the total county contribution to \$842.28 for Fiscal Year 2023-2024; Commissioner Billedeaux seconds the motion; motion carried.
