He explains that the new policy was developed by the Sheriff's Department, Lexipol and MACo. We have sent it to the Glacier County Attorney for approval. We will approve it by resolution at the next meeting Monday, August 21, 2023.

Michael Kittson, Glacier County Human Resources Director presents Resolution No. 2023-11 FY2024 Elected Officials Compensation for approval. The Glacier County Compensation Board met on Tuesday, August 8, 2023 with the following recommendations for the FY2024 Elected Officials Compensation base pay to \$55,200.00 excluding the Sheriff and County Attorney's salaries. As well as a 7% COLA increase for the Glacier County Employee's.

## GLACIER COUNTY RESOLUTION FY2023-2024 ELECTED OFFICIALS COMPENSATION AND COUNTY EMPLOYEE COST OF LIVING ADJUSTMENT RESOLUTION NO. 2023-11

WHEREAS, Montana Code Annotated(2021)(MCA)§ 7-4-2503, provides that a compensation schedule for the County's elected officials must be established based upon a recommendation submitted by the County Compensation Board; and,

WHEREAS, the Glacier County Compensation Board, comprised and appointed in accordance with MCA §7-4-2503(4)(a), has, pursuant to MCA§7-4-2503(4)(b), conducted public hearings and considered economic variations and factors; and County Compensation Board, by majority vote as required in MCA§7-4-2503(4)(c), has established a recommendation for a salary schedule for the County Elected Officials; and

**WHEREAS,** MCA § 7-4-2503(1)(b) provides that the salary paid to the County's elected officials must be uniform; and

WHEREAS, MCA § 7-4-2504 provides that the Board of Glacier County Commissioners shall, by resolution by the date established in MCA§ 7-6-4036 (1)(a) each year, set the salaries of elected County Officials; and

**WHEREAS,** The County Compensation Board has established a uniform base salary, for the elected Glacier County officials, by evaluating the consumer price index as calculated by the U. S. Department of Labor, Bureau of Labor Statistics, as well as compensation paid to comparable Montana counties, to formulate a fair compensation for elected officials; and

WHEREAS, The Glacier County Board of Commissioners historically establishes a salary increase for employees when the Compensation Board recommends wage increases or cost of living, the Glacier County Board of Commissioners has established a **7%** cost of living increase for all employees, whereas other governing boards (Library and Museum) may set their own salaries per an adopted resolution to be recorded by the County Clerk and Recorder; and

**WHEREAS,** In accordance with MCA §7-4-2107, each member of the Board of County Commissioners shall receive an annual salary equal to the Clerk and Recorder plus \$2,000; and that in accordance with MCA §7-4-2503(2)(b), county sheriff must receive, in addition to the

base salary, the sum of \$2,000 a year, and that in accordance with MCA §7-4-2503(2)(f), the county treasurer, clerk of district court, and justice of the peace may each receive, in addition to the base salary, up to \$2,000 a year, and that in accordance with MCA §7-4-2503(2)(a), the elected county superintendent of schools must receive, in addition to the salary, the sum of \$400 a year.

**NOW, THEREFORE, BE IT RESOLVED,** by the Board of County Commissioners of Glacier County, Montana that effective as of July 2, 2023, the base salaries for the elected officials of Glacier County for fiscal year 2023-2024 are set per the recommendation of the Glacier County Compensation Board as follows:

**BE IT FURTHER RESOLVED,** by the Board of County Commissioners of Glacier County, Montana, that effective July 02, 2023, the salaries for the employees of Glacier County are to be increased by **7%** for the cost-of-living adjustment, and that this resolution, upon adoption, will be effective for the Fiscal Year 2023-2024. Other Glacier County governing boards (Library, Museum, etc.) must approve their own cost of living adjustments and file with the Clerk and Recorder and Human Resources.
