C. BUDGET HEARING (9:00 a.m.): FY2023-2024 Permissive Group Benefits Levy

Chancy Kittson, Glacier County CFO explains this is a levy that allows the counties to fund increases in group benefits for medical and the formula is provided by the State. This year the mills for the permissive group benefits levy is 2.20, equivalent to \$72,153.00. Commissioner Billedeaux asks if there is any public comment.

NOW, THEREFORE BE IT RESOLVED, that the Glacier County Board of Commissioners approve and adopt the final budget for the fiscal year beginning the 1st day of July, 2023 and ending the 30th day of June, 2024.
