C. Discussion/Approval: County Compensation Board, FY2024 Premium Pay to Elected Officials from the federal Coronavirus State and Local Fiscal Recovery Funds of \$1,500.00.

Glacier County Human Resources Director Michael Kittson presented the grant obtained by CFO Chancy Kittson. The federal Coronavirus State and Local Fiscal Recovery Funds has a

section that approves the payment of Premium Pay similar to the federal ARPA and CARES funds. The Board of Commissioners has approved all county employees who are still working with the county and have worked between 2019 and May 11, 2023 eligible for the premium payment of \$1,500.00. HR Director Kittson discussed the dedication of all county employees who worked during the covid pandemic. He also asks the County Compensation Board to approve the same payment to the elected officials of Glacier County.

Commissioner Billedeaux comments about the dedication of county employees during the pandemic. Commissioner Overcast comments about doing good things for the employees now that we have finances under control, and this is a federal grant not local taxpayer money. Chairwoman Bremner extends comments about how she was initially against the payment but discussing with the CFO and HR Director and examining the finances of Glacier County she was comfortable with the payment.

Board member Ken Hoyt offered his support for the payment as well as Sheriff Redhorn. Board member Lauri Elhard asked about what the money can be spent on. HR Director Kittson referred her to the federal register Vol. 88, No.181 of September 20, 2023, of the eligible uses and the restrictions of the grant monies. HR Kittson added this payment would account for approximately less than 10% of the amount of the grant. Treasurer Wilson added positive comments for the payment for the employees and offered his support.

County Attorney Matt offered a motion to pay the Glacier County Elected Officials a onetime premium payment from the Coronavirus State and Local Fiscal Recovery Funds of \$1,500.00. The motion was seconded by Clerk of District Court Twila Pyette. Roll Call for votes was taken and recorded as follows:
