G. Discussion/Approval: Repair Road Department Water Tank (Estimate: \$10,480.00) – John "Snoop" Evans, Glacier County Road Supervisor

Jimmy Racine, Glacier County Road/Weed Dept explains that the road department has one water tank that they use for the repair of roads in the warm months. It has been losing a large amount of water before they get to the job due to wear and tear of the tank. He explains that they have looked into purchasing a new tank, but it would be very costly. The solution is to repair the current tank. We did get a quote from Pack Construction, LLC in the amount of \$10,480.00 to repair the water tank. Therefore, we are present to get approval to go forward with the repair. There is a discussion, and the commissioners agree this is a much-needed repair so that the road department is ready in the spring when it is most needed.
