Glacier County Commissioners Monday, December 18, 2023 Regular Meeting Cut Bank, MT

The Glacier County Board of Commissioners met at a regularly scheduled meeting at 9:00 a.m. on Monday, December 18, 2023. Commissioners Mary Jo Bremner, Vernon "Napi" Billedeaux, & John B. Overcast were present. Mandi Bird Kennerly taking minutes.

A. Roll Call

The meeting was called to order at 9:00 a.m.

B. Approval of Agenda

Commissioner Overcast motions to approve the agenda with no changes; Commissioner Billedeaux seconds the motion; motion carried.

NEW BUSINESS:

C. Discussion/Approval: Cut Bank Airport Funding Report – Rick Geiger, Cut Bank Airport Authority County Representative

Rick Geiger, Cut Bank Airport Authority gives a handout to the commissioners to help go over the funding for the Cut Bank Airport. He states that the airport may have enough money to get them through the end of the year. He explains that the airport is very concerned that they may not have enough money after the first of the year. There is a discussion on the mills that Glacier County provides and that the Cut Bank Airport Authority has visited with Terryl Matt, Glacier County Attorney but the determination was that the county couldn't allocate more than what the original agreement stated. Mr. Geiger would like to get a working session started between Glacier County, City of Cut Bank and the Cut Bank Airport Authority to brainstorm some options. Chancy Kittson, Glacier County CFO states that he did some research, and the airport will have enough to finish the fiscal year with the director taking a cut in hours. There is further discussion on grants, amending the previous resolution and arranging a meeting with both attorneys from the City of Cut Bank & Glacier County. It is decided that Commissioner Overcast will go to the meeting and have the attorneys research this to the full extent.

D. Approval: Governmental Lease Purchase/Motorola/ (20) APX 8000 All Band Portable Radios, (17) APX 8500 All Band Mobile Radios and (2) APX Consolettes (Total Purchase Price \$496,746.81) – Chancy Kittson, Glacier County CFO/Glacier County Commissioners

Tom Seifert, Glacier County Undersheriff presents the commissioners with a Government Lease Purchase from Motorola for (20) APX 8000 All Band Portable Radios, (17) APX 8500 All Band Mobile Radios and (2) APX Consolettes (Total Purchase Price \$496,746.81). He explains that the Sheriff's office has been having issues with their current radios and ultimately the current radios are dated and will need to be replaced. There was an incident where a radio didn't work properly, but they were lucky that nobody was affected. The commissioners agree that due to the safety of the community and staff this is a need right away in the county to avoid a catastrophic event. Chancy Kittson, Glacier County CFO states that he can budget two years through the ARPA funding and that a grant coming out could cover the rest of the cost. Ultimately, there will be a plan in place to cover the cost of this purchase.

E. Discussion/Approval (10:00 a.m.): Glacier County Browning Satellite Office Final Preliminary Plans (site improvements) – Glacier County Commissioner/Robie Culver, Stahly Engineering Grant Specialist

Robie Culver & Tanner Pankratz, Stahly Engineering present the commissioners with the Browning Satellite Office Final Preliminary Plans. They go through the plans with the commissioners so that they can plan for construction and start moving forward on the upgrades to the location. No decision is made.
