Resolution No. 2024-02**

A RESOLUTION AND ORDER BY THE BOARD OF GLACIER COUNTY COMMISSIONERS CHANGING BOUNDARIES OF CERTAIN PRECINCTS IN GLACIER COUNTY, MONTANA, IN ACCORDANCE WITH THE 2023 RE-DISTRICTING AND APPORTIONMENT PLAN PURSUANT TO SECTION 13-3-102, MCA: AND MODIFYING BOUNDARY LINES AND CREATING NEW SPLITS

WHEREAS, pursuant to Section 13-3-102, MCA, the county governing body is required to make precinct boundaries conform to legislative district boundaries following the adoption of a State districting and apportionment plan, and

WHEREAS, on the 2nd day of April, 2013, the Glacier County Commission adopted Resolution No. 2013-07 filed with the Clerk & Recorder, adopting precinct boundaries in Glacier County, Montana, And

WHEREAS, it is the intent of the governing body to change a number of boundaries and identify the boundaries of all Glacier County Precincts, and

WHEREAS, during review of all current precincts, it has been determined to change boundary lines for Precincts No. 8, 9, 10, 12, 13, 19 and 21c and create new splits in Precincts 10 and 19 due to School District boundaries within the County of Glacier

NOW THEREFORE BE IT RESOLVED, by the Board of Commissioners of Glacier County, State of Montana, that the presently established the changes of boundary lines in Precincts No 8, 9, 10, 12, 13, 19 and 21c and the creation splits for Precincts No. 10 and 19 are within the Conty of Glacier

FURTHER, BE IT RESOLVED, that in compliance with Section 13-3-102, MCA, of the Election Laws of the State of Montana, the precinct boundaries of Glacier County are hereby approved and adopted, and

FURTHER, that the precincts within Glacier County shall be established in accordance with the boundaries described herein as Exhibit "A".
